- ii. Mary Grace Edrosa stated that, in honor of CGFM Month, on Mar. 4, 2022, the Office of the Governor held a virtual Proclamation Signing and the Office of Senator San Agustin held a Legislative Resolution Presentation.
- iii. Grace announced the availability of the CGFM Study Guide 1 to be loaned to interested members; and the special CGFM Application Promotion of a free exam for test applicants in March.
- iv. Grace stated that to apply for the CGFM Certification, members would need to read the code of ethics, apply for the CGFM program, and submit required degree documentation.
- v. Josie thanked those who attended the free training held on Mar. 18, 2022: "Finding that Balance: Becoming a Personal Financial Manager". The Chapter had about 120-130 attendees.

- c. Community Service by Margie Castro

 - iii. 60-Minute Community Service until Apr. 30, 2022: Members can do solo community service or collaborate on activities to earn service credit. Members are to self-certify by emailing their photo and description of date and service to the Chapter email.
- 6. Guest Speaker's Presentation
 - a. Dr. Raymond Johnson, CPA, of the Portland State University and traveling professor for the University of Guam, presented on "Evolution of the Accounting Profession Professional Values and Trends". His presentation covered the following.
 - i. A questioning mindset is the ability to look at data thoughtfully. It is the application of:
 - 1. an inquiring mind when collecting and assessing data and information.
 - 2. techniques that reduce bias when solving problems, informing judgments, making decisions, and reaching well-reasoned conclusions.
 - 3. critical thinking when identifying and evaluating alternatives.













- ii. Trends in accounting and auditing show a shift from manual to automated workflows, adopting new technology, and preparing for fraud. The more routine the work, the more it is susceptible to being replaced by technology.
- iii. Data analytics and artificial intelligence are your friends.
- b. Maripaz asked the attendees to complete the presentation evaluation upon check out from conference.io. She added that the conference.io and Zoom attendance lists will be reconciled.

7. New Business

- a. Maripaz asked the members to nominate individuals for AGA National awards, such as the Emerging Leader Award of Excellence, Volunteer of the Year Award, and Frank Greathouse Distinguished Leadership Award. The individuals do not have to be AGA members. Applications are found on the AGA National website (https://www.agacgfm.org/About/Awards-Recognition.aspx) and on the Chapter newsletter. Applications are due by Apr. 15, 2022.
- b. Maripaz stated that today was the inaugural integration of conference.io with Zoom. The integration helps the committees ensure that members receive their Continuing Professional Education units, polling responses are quickly viewed for an engaging presentation, and questions are compiled. Maripaz thanked those who helped test the platform for their volunteered time and efforts in servicing our members.
- c. Maripaz reminded for members to renew their membership by Mar. 31, 2022.
- d. Maripaz stated that the Chapter will be conducting a short membership survey, which will be emailed to the members within the next two weeks. Members are encouraged to respond to the survey to help the Chapter provide improved services.
