#### 1. Call to Order

a. Meeting was called to order at 11:28 a.m. and was presided by Maripaz Perez.

#### 2. Approval of Minutes

a. A motion to approve the Oct. 2021 General Membership Meeting minutes, subject to corrections, was made by Doreen Crisostomo-Muña. Pilar Pangelinan seconded the motion. The motion carried, but polling was not conducted.

### 3. Treasurer's Report

- a. Financial Report
  - i. As of 9/30/2021:
    - 1. The Statement of Financial Position showed total assets and total liabilities and equity at \$58,311.62.
    - 2. The Statement of Activities showed total income at \$6.65, total expense at \$499.00, and excess of expense over income at \$(492.35).
  - ii. As of 10/31/2021:











- 1. The Statement of Financial Position showed total assets and total liabilities and equity at \$54,507.41.
- 2. The Statement of Activities showed total income at \$61.26, total expense at \$3,865.47, and excess of expense over income at \$(3,804.21).
- iii. A motion to approve the Sept. and Oct. 2021 financials was made by Doreen. Josephine Villaneuva seconded the motion. The motion carried, but polling was not conducted.

## 4. Committee Reports

- a. Accountability (Citizen-Centric Report or CCR) by Doreen
  - i. Dr. Doreen Crisostomo-Muña, Accountability Director, presented on the "Fiscal Year 2020 Best Citizen-Centric Report Award for the Government of Guam".
    - 1. The CCR was an initiative that began in Spring 2009 with student presentations of their CCR projects at AGA's monthly meetings. Among those students were Rizalito Paglingayen and Joy Bulatao. Former Senators Judith Guthertz, Rory Respicio, and Judith Won Pat introduced a bill for this initiative, which became Public Law (P.L.) 30-127 when former Governor Felix P. Camacho signed the bill on Apr. 2, 2010.
    - 2. Agencies are required to submit their CCRs to the Public Auditor and the Speaker of *I Liheslaturan Guåhan* no later than 60 calendar days after the Office of Public Accountability (OPA) releases the agencies' independent auditor's report. The agencies are also required to post their CCR on their website.
    - 3. The annual Government of Guam CCR awards was started by Maripaz in Fiscal Year 2012. CCRs of agencies were evaluated by 15 evaluators against P.L. 30-127's requirements and were awarded based on their scores.
    - 4. Based on the Committee's review, 34 agencies submitted good CCRs. However, some agencies described their infrastructure on page 2 Performance Measures instead of page 4 Entity's Challenges and Economic Outlook. Of the 34 agencies, those selected for awards were: the OPA  $-3^{rd}$  Place (Bronze), the Guam Behavioral Health and Wellness Center – 2<sup>nd</sup> Place (Gold), and Guam Housing Corporation – 1<sup>st</sup> Place (Platinum).
  - ii. Maripaz thanked Doreen for the presentation and the agencies for their contributions in developing and improving accountability and transparency in our government through their CCRs.

- iv. In honor of Veteran's Day, the Chapter supported the "Wreaths Across America" campaign through a sponsorship of 10 wreaths to be displayed at the Guam Veterans' Cemetery in Piti on Dec. 18, 2021.

#### 5. Guest Speaker's Presentation

- a. Jesse Quenga, Executive Director of the Guam Ethics Commission, presented on "Guam Ethics Commission: Mission, Trainings, and Addressing Public Concerns".
  - i. The Commission was re-established through P.L. 27-141 by the late Speaker Vincente "Ben" Pangelinan and became active in 2019 through Governor Lou Leon Guerrero's appointments to the Commission. The Commission's independence was reaffirmed through P.L. 36-28. The Commission was granted more autonomy and direct access to its local appropriations by the Guam Legislature.
  - ii. The Commission's main purpose is to hold government officers and employees accountable to the ethical standards established by Guam law. All employees are mandated to undergo an ethics in government training. The deadline for compliance depends on the employee's hiring date: 36 months if hired prior to May 12, 2021, and 6 months if hired after May 12, 2021.
  - iii. The Commission can hear complaints up to three years prior and past the statute of limitations under certain conditions. However, the Commission has not heard formal complaints and is pending a legal counsel (as authorized by Bill 205-36) to guide them in their deliberations.
