As mentioned, we will try to provide CPEs that are forward thinking and will help in future proofing us in our profession. Our August speakers will be Kunn Richard Ryu and Keith Elliot from Ernst & Young, who will be speaking about "Digital Transformation through RPA (Robotics Process Automation)" and will give some examples based on work with the Guam Power Authority.

The idea behind RPA isn't to get rid of accountants, but to streamline repetitive processes to allow for more efficiency in analyzing financial data. The discussion is aimed to help us understand the process and to assure us that accountants will still be needed.

CGFM EXAMINATION UPDATES

The CGFM Examination will be updated starting September 01, 2019. The schedule of the update is as follows:

- 1. **Starting on September 1,** the CGFM examinations will follow the updated content outlines.
- 2. From **September 1 to October 31,** CGFM examinations will be in the initial (beta) period. The updated examinations will be administered in Pearson VUE testing centers; however, the scores will not be immediately reported to the candidates taking these examinations. The scores will be reported by December 31, 2019. **CGFM Examinations taken during this beta period will be offered at a discounted rate of \$100 per exam.**
- 3. There will be no CGFM examinations administered in November or December 2019.
- 4. **Starting on January 1, 2020,** the updated CGFM examinations will resume (with immediate score reporting).

The Certified Government Financial Manager (CGFM) is a professional certification recognizing the unique skills and special knowledge required of today's government financial managers. It covers governmental accounting, auditing, financial reporting, internal controls and budgeting at the federal, state and local levels. Guam also promotes study groups to assist its members.

Interested in attaining the CGFM Certification?

Your AGA Guam Chapter:

- → Offers CGFM Scholarships to reimburse your registration and test fees when you pass the CGFM examination within your CGFM eligibility period.


