#### 1. Call to Order

a. Meeting was called to order at 11:34 a.m. and was presided by Maripaz Perez.

## 2. Approval of Minutes

- a. Maripaz apologized for an oversight in emailing/attaching meeting minutes and financial reports from previous months. The minutes and reports were posted in chat.
- b. A motion to approve the Nov. 2021 and Jan. 2022 General Membership Meeting minutes, subject to corrections, was made by Taling Taitano. Jojo Guevara seconded the motion. The motion carried, but polling was not conducted.

# 3. Treasurer's Report

- a. Financial Report
  - i. As of 10/31/2021 (Revised):









- 1. The Statement of Financial Position showed total assets and total liabilities and equity at \$54,754.03.
  - a. Llewelyn reported that the accounts receivable of \$150 was from the Guam Department of Education's registration for the Guam Professional Development Conference.
- 2. The Statement of Activities showed total income at \$307.88 (vs. the \$61.26 previously reported), total expense at \$3,865.47, and excess of expense over income at \$(3,557.59) (vs. the \$(3,804.21) previously reported).
- 3. Llewelyn explained that the revision was due to PayPal donations accessed after presenting the Oct. 2021 financials.
- ii. As of 11/30/2021:
  - 1. The Statement of Financial Position showed total assets and total liabilities and equity at \$55,082.09.
  - 2. The Statement of Activities showed total income at \$328.06 from donations, total expense at \$0, and excess of expense over income at \$328.06.
- iii. As of 12/31/2021:
  - 1. The Statement of Financial Position showed total assets and total liabilities and equity at \$55,082.09.
  - 2. The Statement of Activities showed total income, total expense, and excess of expense over income at \$0.
- b. A motion to approve the Oct. 2021 (Revised), Nov. 2021, and Dec. 2021 financials was made by Taling. Josephine Villanueva seconded the motion. The motion carried, but polling was not conducted.

#### 4. Committee Reports

- a. Membership Committee
  - i. Jojo introduced himself as the Co-chair for the Nominating Committee. Nominations are open for the Program Year 2022-2023 President-Elect, Secretary, and Treasurer-Elect positions.   - ii. Maripaz added that, if you would like to serve, please email her, Jojo, or the Chapter. We would love to see new members take on leadership role. We also look forward to this year's rebranding and transformation of AGA National.
- b. Scholarship Committee
  - i. Maripaz stated that the Chapter awards scholarships every Spring and Fall semesters to the University of Guam (UOG) and Guam Community College (GCC) students.
  - ii. Lorbea Kim presented the AGA Guam Chapter scholarship program. The program was established to advance government accountability and









- transparency in all government levels by reaching out to accountability professionals from accounting technicians to accountants. This scholarship is open to students pursuing an Associate's degree in Accounting at the GCC. Alisha Candoleta and Cheryl Guyton-Mafnas were each awarded \$500.
- iii. Lorbea presented the Herminia Dierking scholarship program. The program was established in recognition of the achievements of the late Herminia Dierking. Mrs. Dierking was a prominent figure in the community and in the accounting field. This scholarship is open to students pursuing a Bachelor's degree in Accounting at the UOG. Mariah Castro and Tiffany Concepcion were each awarded \$1,000.
- iv. Lorbea stated that the Spring 2022 scholarships were made possible by the joint funding of the Chapter and private sector contributors.
- c. Community Service by Margie Castro
  - i. The Community Service and the CGFM Committees are hosting a donation drive for Sanctuary Inc. through Mar. 25, 2022. Personal hygiene products (e.g., shampoo, deodorant, etc.) are being sought for children staying at the Sanctuary's shelter. - d. CGFM Committee by Josie

## 5. Guest Speaker's Presentation

- a. Pilar reminded the membership to use Conference.io to ask questions to the speaker and answer polls. Participants must be logged in and actively participating for at least 50 minutes to obtain one CPE.
- b. Edmund Brobesong, Senior Tax Manager, and Minako Sakuta, Senior of the tax team at Ernst & Young, LLP, presented on "2021 Tax Update".
  - i. The 2021 standard deductions are \$12,550 for single/married filing separately, \$18,800 for head of household, and \$25,100 for married filing jointly.
  - ii. If a taxpayer did not receive the full amount of the third economic impact payment, the taxpayer may be eligible for the recovery rebate credit. The credit could reduce the amount of tax owed or be included as a tax refund. The maximum credit is \$1,400 per person, including all qualifying dependents claimed on the tax return.
  - iii. The place to file tax returns is determined by residency or citizenship. A bona fide resident of Guam must file returns on Guam. If a green card holder is residing in the Philippines, then the holder must file tax returns with the U.S. Internal Revenue Service. Any green card holder is a U.S. resident. The only way the holder would file a return on Guam is if the holder is a bona fide resident of Guam.
