5. **Guest Speaker:** Doris Flores Brooks, Guam Public Auditor

Topic: Basics of Government Finance

The Public Auditor discussed the FY 2015 financial audit, Federal Government debt, and noted the following:

- The Government of Guam (GovGuam) should "live below our means".
- The debt has to be managed. The Federal Government is a lot worse with an amount of \$18.2 trillion. We promise more than what we can afford. It is a matter of Congress making basic decisions.
- All other states have rainy day funds.
- GovGuam has a negative net position. The deficit may be going down, but we are not reducing the debt burden. Passing the liability down.
- Federal Government and Guam have not been following the basic concept of living below our means. She also highlighted two videos from the AICPA: 1) What's at Stake? The CPA Profession's Views on the Federal Financial Picture; and 2) What's at Stake? A CPA's Insights into the Federal Government's Finances.
